Subject: SAFETY RECALL NOTICE

Dear BFGoodrich Tire Owner,

This notice is sent to you in accordance with the requirements of the National Highway Traffic and Motor Vehicle Safety Act.

BFGoodrich, a brand owned and operated by Michelin North America, Inc., has decided that a defect which relates to motor vehicle safety exists with certain **BFGoodrich Commercial T/A All-Season, BFGoodrich Commercial T/A All-Season 2, and BFGoodrich Rugged Terrain T/A tires, and they are included in a safety recall.**


These replacement market tires are primarily found on commercial light trucks, as well as full-sized heavy-duty vans, small RVs, and some 3/4 and one ton pick-up trucks. The recall involves approximately 104,000 tires sold in the U.S.

BFGoodrich has observed that a limited number of these tires have experienced a rapid loss of air pressure due to a rupture of the sidewall in the bead area under severe usage conditions. This can result in a potential risk of loss of vehicle control or vehicle crash. At this time there have been no injuries or fatalities reported.

You are receiving this letter because our records indicate that you may have purchased one or more of the recalled tires. The following list provides the product descriptions, DOT (Department of Transportation) sequence identifiers and DOT production periods of the manufacturing populations which contain the recalled tires. The DOT information is molded to the sidewall of each tire: the DOT sequence number and DOT date code that is a 2-digit week and 2-digit year of production, which are given in the DOT production period information. For example, "4314" refers to the 43rd week of the year 2014.

HOW TO READ THE DOT



Tires matching these descriptions, DOT sequence identifiers and DOT production time periods are part of the recall population. All impacted tires were manufactured in 2014 and 2015; if you purchased your tires prior to that time you are not impacted by this recall. To determine if your tires are included in this recall, please check the DOT information found on the sidewall of the tire, and if they match the above identifiers, contact your local authorized BFGoodrich retailer. If possible, please take back the tires to the tire retailer you purchased them from. If that is not possible or convenient, please locate a BFGoodrich retailer on the dealer locator at www.BFGoodrichtires.com.

It is important that all recalled tires be removed from service as soon as possible. The removed tires will be replaced with a similar product at no cost up until February 10, 2017. After that time the recalled tires will be processed as part of our standard warranty policy.
